

## Minutes of

## The Annual General Meetings of the Institute of Refrigeration

Charity Registration no 1166869 held at 4pm on 5th November 2020 by webinar

The President welcomed members to the AGM. Apologies had been received from Paul Singh and John Ellis. The CEO had received 6 proxy votes in advance.

- 1. The minutes of the Annual General Meeting held on 6th November 2019 as distributed and published on the website <a href="www.ior.org.uk">www.ior.org.uk</a> were proposed by the President and agreed with a show of hands with 35 votes in favour, 2 against and 1 abstention (including the 6 proxy votes).
- 2. The Annual Review and Report of the Trustees for the year ended 31st March 2020 as published on the website and summarised in a sheet circulated with the agenda were discussed by the President who drew attention to achievements and priorities for the year as well as plans for 2020/21. The President proposed that the Annual Report be accepted, and this was agreed by a show of hands, with 36 in favour, 2 against and no abstentions, including the proxy votes.
- 3. The Financial Report of the Institute was given by the Honorary Treasurer who outlined the years financial performance against budget and levels of reserves. He proposed that the Audited Accounts and Balance Sheets for the year ended 31st March 202 as published on line be accepted. This was agreed by a show of hands with 37 in favour (including proxy votes), 1 objection and 1 abstention.
- 4. The Treasurer proposed that auditors for the next set of accounts, Myrus Smith and Partners of Sutton, Surrey be appointed and that Board of Trustees be authorised to agree remuneration. This was agreed by a show of hands with 37 in favour, no objections and one abstention (including proxy votes).
- 5. The Treasurer proposed that members approve the Board of Trustee motion that the subscription rates be held with no increase for the year commencing 1<sup>st</sup> April 2021 as below. This was agreed by show of hands with 39 in favour including proxy votes, and no objections or abstentions.
